SPRINGS VALLEY COMMUNITY SCHOOLS CIVIL RIGHTS NONDISCRIMINATION GRIEVENCE PROCEDURE FOR INDIANA'S CIVIL RIGHTS COMPLIANCE PROGRAM FOR VOCATIONAL EDUCATION

- 1. Applies to Regulatory TITLES VI (race,color,national origin), TITLE IX (sex), Section 50% of the Rehabilitation Act of 1973 (handicapping condition), and the Indiana State Board of Education Advisory Committee V-Rules Requirements and the guidelines developed by the Indiana Department of Education, Vocational Education Section.
- 2. Interested parties include school corporation efficers, employees, students and entrons.
- 3. Applies to acts or omissions relating to protected rights based upon age, race, color, religion sex, handicapping conditions, and national origin, including limited English proficiency.
- 4. Civil Rights Compliance Coordinator
  - 1. The building principal or designee for allegations of building-level violations to students or building patrons.
  - The superintendent or designee for allegations and violations of a corporate level such as policy or practice.
- 5. Civil Rights Compliance Officer
  - 1. The superintendent of schools or designee
- 6. The Process
  - A. Level One
    - 1. The officer, employee, student, or patron alleging a violation shall submit the intitial complaint in writing to the appropriate compliance coordinator described in #4 above. The complaint shall stipulate the specific act or omission, the late of same, and parties involved.
    - 2. The compliance coordinator shall initiate investigation of the diremstances of the complaint within seven (7) calendar days of the receipt of the written complaint.
    - 3. The compliance coordinator shall render a decision within fourteen (14) calendar days of the receipt of the written complaint. The decision shall be in writing to the complainant.
    - 4. The complainant shall have seven (7) calendar days to react to the decision before it becomes final. If the complainant disagrees with the decision of the complaince coordinator and submits such a statement in writing to the compliance officer, a level two procedure shall be enacted.
  - B. Level Two
    - 1. The compliance coordinator shall submit the written disagreement statement and all related information to the superintendent within three (3) calendar days of receipt.
    - 2. The superintendent shall review all material and schedule a meeting within seven (7) calendar days of receipt of the written disagreement and all related information. The participants shall be the complainant, the complained coordinator, and the superintendent. Other withnesses may be called with mutual prior notice of three (3) calendar days.
    - 3. The superintendent shall make a decision within seven (1) calendar days of the final meeting of parties. This decision shall be final.
- 7. NOTE: By mutual agreement circumstances of calendar availability may result in extension of stipulated time allowances if a request is made in writing by either party and so agreed to by the parties.
- 3. NOTE: If the alleged violation, interpretation, or application is of a corporate nature suce as a written rule, regulation, or policy, then level Two is initiated immediately.
